## Research Articles

Leonardo Quadrio, Scuola normale superiore, Pisa Discourses of Barbarism in Haiti. Between Colonial Demonisation and Re-Appropriation by the Colonised (1791-1820)

This study examines how the dehumanizing stereotypes constructed by French colonial power during the Haitian Revolution (1791-1820) influenced the formation of the new Haitian State. The French depicted African and Afro-descendant insurgents as barbarians and cannibals to justify potential recolonization. However, Haitian élites reappropriated and inverted these stereotypes, using them to delegitimize French claims and denounce the horrors of the colonial system. The paper further explores how these redefined images helped shape Haitian national identity – at least in the minds of the new élites – and played a significant role in the civil conflict between Christophe's northern kingdom and Pétion's southwestern republic.

Michele Finelli, Università Roma Tre At the School of Democracy. Mazzini's Pedagogical Journals between Italy and Britain (1830-1844)

Between June 1842 and June 1844, the Scuola italiana di Londra, founded by Giuseppe Mazzini, published two periodicals, «Il Pellegrino» and «L'Educatore». Although limited, their experience provides an insight on the role that Mazzini and the republicans played in the debate on education stimulated by the rising Italian pedagogical press since the 1830s. By investigating the part taken by these periodicals in the debate, the article analyses the crucial importance that the battle for education acquired for the democratic movement. Were «Il Pellegrino» and «L'Educatore» purely didactic publications? Were they also used to promote the Italian cause among the English public? The article will also explore the influence

that both the broader European debates on education and historical novels that were popular at the time possibly exerted on the two periodicals.

Ginevra Villani, Università di Padova-EHESS «Is London truly so vast? Yet, all speak only of me!». Adelaide Ristori, a celebrity beyond the channel

This article investigates the construction of Adelaide Ristori's international celebrity during her 1856 tour of Britain, placing it within the broader emergence of nineteenth-century celebrity culture. Based on unpublished correspondence, contemporary press coverage, and visual materials, the study emphasizes the strategic role played by her husband, Giuliano Capranica del Grillo, in shaping her public persona. The analysis foregrounds the interplay between theatrical performance, media representation, and aristocratic sociability in the consolidation of Ristori's fame. The article argues that Ristori came to embody not only the figure of the celebrated actress, but also a symbolic representation of national and maternal ideals within the context of the Risorgimento.

Irene Polimeni, Scuola superiore di Studi storici, Repubblica di San Marino Repressing and Legitimising. Luigi Ajossa in the Kingdom of the Two Sicilies, 1848-1860

This article examines the repression of political dissent in the Kingdom of the Two Sicilies under Bourbon rule after the 1848 revolution, by focusing of the political biography of Luigi Ajossa, a high-ranking state official whose action exemplifies the perspective of the state apparatus. Administrator of Bari and Salerno, Police Director in 1860, and a conspirator in the Bourbon resistance against the Italian Risorgimento, he became a target of the delegitimizing narratives of the Italian national and liberal forces, particularly following the defeat of Carlo Pisacane expedition in 1857. Ajossa's experience highlights the role of provincial officials in police control and local administration, which were both crucial for political legitimation. The counterrevolutionary era in the Bourbon state emerges for its marked conservative and reactionary nature.
